OFFICE MEMORANDUM

All the establishments covered under National Apprenticeship Training Scheme (NATS) by this Board, are hereby informed that the full scale DBT implementation for the active apprentices will be done from February 2024. Therefore, in this regard as informed vide our earlier emails and phone calls, the concerned officials of the establishments having active Graduate/Technician apprentices on their roll, are now requested to visit DBT dashboard in the establishment login to find out the apprentices who are facing either DBT beneficiary registration warning or rejection on NATS 2.0 portal and go through the guidelines to resolve the issue related to DBT beneficiary registration. The establishment officials are requested to inform the apprentices to take appropriate action on the issues as per the guidelines provided on each issue. It may please be noted that a 1-week window has been provided on the said portal from **08/01/2024 to 15/01/2024**, to edit the Aadhar and Bank details for all those apprentices who had entered wrong details by mistake, or any other reason. After this period this editing option will be closed.

The apprentices should be informed by the establishment officials that, following steps should be followed by the apprentices:-

Step 1:- Log in to the NATS 2.0 portal with credentials.

Step 2:- In the student dashboard, below the navigation bar there is a scrolling notification (marquee) saying "Have you provided the wrong Aadhar or wrong bank details while registering? Click here to rectify your Aadhar Number/Bank details"

Step 3:- The existing details will be prefilled, which can be replaced with the correct details.

In the interest of apprentices, the establishment officials are hereby appealed to take up this matter on priority and do all needful so that the beneficiary registration for all their active apprentices is made successful. They may contact the concerned officer in charge of this Board for their establishment's location, for any further clarification.
